## About this Book

In 2006, Republican super-lobbyist Jack Abramoff pleaded guilty in two separate jurisdictions, Washington, DC and Florida, to various corruption charges in what has become the most high profile corruption scandal to ever grace Capitol Hill. Bradford also reveals why Abramoff's efforts on behalf of this tribe so upset the liberal status quo, that the Native-American establishment endeavored to remove him permanently from Indian Country. The scandal played out in the Senate Indian Affairs Committee, where Sen. John McCain, a pillar of the tribal gaming establishment, held all the levers of power, and witnesses were allowed to

perjure themselves without consequence.

Through a gripping narrative filled with many unexpected twists and turns and explosive revelations, *Lynched* reveals the extent to which separation of powers and the U.S. system of justice are under assault in the United States. This book demonstrates in astonishing detail how special interests aligned to influence the courts, political offices, the media, Congressional Committees, and federal agencies to manufacture a scandal which furthered their political agenda and railroaded an enormously influential conservative lobbyist into prison on trumped up charges.
