## Congressional Bid

I intend to run for a congressional seat this year and will run on the very principals, platform and convictions put forth in 2010. Those attributes are still available at my website in the Archive section of the site. It is not my intention to fly across the United States or spend thousands of dollars on campaign materials in an effort to gain the people's support. I believe in all fairness, the people recognize my dedication to them and Osage government affairs through witnessing my tireless efforts to inform and educate them on the realities and injustices imposed upon them and I believe after 6 long years of helplessness, they are appreciative of my efforts.

I am hopeful that the Osage people have become comfortable and reliant upon my accurate and honest facts and that

they have recognized the importance of honesty, integrity and openness in Osage government affairs. It is my intent to continue informing the people as I do today and have for several years by way of continued newsletters and my website of which will remain active throughout my term of office. It is my belief and the expectation of a democratic government that elected officials remain close to and in contact with their constituency because after all, when the people vote me into office; their votes are a vote to hire me to represent them, not keep secrets from them or ignore them after I begin drawing my paycheck.

## Democratic Government

A democratic government is a form of government in which the sovereign power resides

in and is exercised by the whole body of citizens directly or indirectly through a system of representation. Until laws supporting such democratic principles are carried out by the Osage Nation Congress the idea that we are governed by a democratic government will remain fallacy. Until not only the elected officials but the people come to embrace this concept, the government will not be successful. Because we are faced with this major adjustment of which we have not practiced according to its intent, we are paying the price which is by no means an unintentional act but an intentional act set forth by the framers of this Reform and Constitution.

The power exercised by the people directly or indirectly refers to the Citizens Referendum and Recall initiative of which has not been addressed

by this Congress. Many are the times in the past 6 years that citizens have attempted to petition the Congress to pass legislation to no avail. The instance of Congress members failing to appear for Congressional Sessions has been staggering in some cases indicating that a Recall Initiative was in order. These problems continue to exist and continue to exist intentionally.

This new government is the people's government not the Chief's government; nor the Congress' government. When the people have spoken and are heard, laws should be enacted according to their will, not the will of those representing them. Legislation should come from the people through a Congress member who is willing to Sponsor it by representing an individual citizen or a group of citizens. Those who are elected into any office are elected to be the people's representatives therefore,

public servants of the people.

A solution I propose to correct this situation would be to pass legislation to approve the use of online petitions for groups such as out of state Osages as well as special interest groups to petition the Congress to pass legislation for causes that they wish to have implemented through the government. The process is not as difficult as it may seem. The problem is electing Congress people who will get it done and who understand and accept that they are representatives of the people, not caretakers or dictators.

My trust is in you, the people therefore, I intend to work FOR you. I hope you in turn trust me and work to help me get elected in this 2012 Congressional election. There can be no doubt whatsoever that the currently elected officials, their friends and their family members will do all possible to

keep me out of office. The very idea that I may get elected and hold them accountable for their actions threatens every fiber of their being. Expect to hear ridiculous, unsavory rumors and innuendos about my character. Such tactics were successful in 2010 and look at what has happened to us since then. The telling of untruths to the voting public as we have seen over and over again is unfortunately a characteristic of some who are in office today. I ask that you think and rethink your positions before you vote in this election for the good of the Osage people as a whole.

### **Following the Law**

There is no question that written laws are not respected or adhered to in the new nation government whether they be federal laws or even the very laws written by the nation government itself. The principle of law has a purpose and the purpose is to prevent lawlessness. Until we

put into office people who will read, understand what they read and put into action legal rules and regulations, we will continue to have a lawless government. It is honesty, integrity, the ability to comprehend and the fortitude to research further the laws and facts that are the cornerstone of a dependable, respectable government. Such a government we do not have today. In short, outrageous salaries are being paid to individuals for work that is not being done. A capable individual with integrity, honesty and ability would not drop in to the office for 3 or 4 hours, slam the door behind them and never look back, never answer their phone, never return calls, never inform their constituency or never follow the laws.

Should you elect me, it should be obvious that I

will most definitely serve with integrity and honesty and it should be clear that I have the ability to read, comprehend, research and act on the laws for the betterment of the Osage people. I do all of those things now and have for several years at my own expense and donated time out of concern for the future of the Osage. Being a force inside the government and having the ability to observe first hand insidious acts of corruption is the first step in eliminating the scourge that has befallen the Osage. Rest assured, this scourge I speak of has access to “all” of the money and they will use it against me in this

campaign. I have no access to the people’s money; therefore I have no funds to fight back. The question is; will the Osage people allow corruption to buy the next 6 congress members? Will the Osage people allow their very own revenue from gaming to defeat honesty and integrity or will the Osage people resolve to defeat corruption and take control of their money and their promised government?
