## **MILLER SUSPENDED!**

Having grown accustomed to seeing my Candidacy Articles posted on the Osage News Online, I became concerned when my December Article wasn't made available. On December 15, I sent an e-mail to Shannon Shaw, Interim Editor of the Osage News and asked: "Will you please enlighten me as to why my article has not been published?" This question led to my being suspended from further articles in the Osage News for 6 months.

I am attaching all correspondence that I'm aware of regarding this matter for your review. I am pleased to report that this decision has been reversed and I look forward to getting on with the real business at hand with my January article.

## **ACTS OF DEFIANCE SERIES**

On December 31, 2009, at the stroke of 12:00 midnight Central Time, I will press the send button to kick off the first act (Act I) of Defiance carried out by Jim Gray on behalf of the Osage people. This act began the very month Gray was elected to the 31<sup>st</sup> Council and took over 8 million (possibly 10 million) dollars of tribal funds to settle.

Let me be clear on this project: Those of you who read this newsletter are obviously involved and have the time in your busy schedules to keep up on the issues and problems plaguing the Osage. Many other Osages out there are interested and concerned, but may not have the time or perhaps are unaware of how to get this information.

This project is an effort on my part to consolidate and minimize the reading material in an efficient manner that will allow those who are not aware to become aware in an expeditious manner. I would add that the consensus is that Gray is toast and not a concern but allow me to remind you, he STILL has supporters working for the tribe and these folks need to be looked at with intense scrutiny.

It is with confidence that I will be depending on you, the Osage citizens to get this information to every Osage you see. We have only but ourselves to count on and I'm counting on you to do your very best to print these reports, forward them in your e-mails and go tell it on the mountain!

It has been witnessed that Gray had people walking away from this Act I debacle thinking that

he won the fight. It is up to us to prove otherwise and with this report, surely we're in for a cake walk.

Allow me to assure you that these reports like all other reporting I have done and will continue to do are backed up by documentation.

Let us not assume that Gray is toast, let's work until the last vote is in to make certain he is not re-elected. Let us not focus on just Gray, let us focus on his entourage, his congressional parrots and his Washington crooks. It's time to start looking at the big picture. We're only 6 months from victory. United we stand, divided we fall.

## **UNITED WE STAND**

I implore ALL who read this letter to know and understand that the state of the Osage Nation is BIG. This is not about me and it's not about you. This is about every Osage across the United States of America.

We have a responsibility, a right and a need to stay united as tribal people. I need your help.

have. What I do have is an outlet to get this information in the hands of Osages from the West to the East Coast, from Canada to the Lucian Islands and they are coming to the trough.
