NEW CONGRESS REPORTS

Newly elected Congressman Standing Bear reported on the Osage Shareholders Forum last night confirmations of what I have been reporting to you for quite some time; which is that we were under a Tyrannical Government.

According to Congressman Standing Bear, while attempting to access a Google search engine from the congressional office, he was denied access. When inquiring as to why he wasn't able to access the search engine, the Congressional office staff stated that the Executive Staff (Gray Administration) had blocked access to it as well as other Internet sites to include Osage Shareholders website.

Needless to say, Congressman Standing Bear recognized this for what it was, suppression and oppression of the Osage Nation Congress. Such actions are typical of Tyranny and/or Communism, plain and simple. As expected, our new Congress member is up in arms and has taken steps to put an end to this and most likely any other form of oppression in place on the hill.

What we have to take a look at is this: What were the 12 Congress members thinking and doing about this atrocity during their 4 year stint as members of the Congress? Why would any of them allow and accept such an action? The answer is that they

Keep in mind that we still have 6 "old" members in Congress who will not be up for re-election until 2012. These Congress members should be watched very carefully and one of the six needs to be removed for not only excessive absenteeism but for being a supporter of Tyranny and the Tyrant himself. We should also keep in mind that two incumbents were re-elected during this election. Raymond Red Corn and William "Kugee" Supernaw retained their Congressional positions and four of the old 4 year termers didn't run for re-election.

Red Corn and Supernaw both kept the citizenry informed with Updates and Notes to the Nation. Though both were in conflict with one another on issues and one did actually support this Tyrannical Government more so than the other, I expect to see changes for the better now that Gray is no longer able to control the Congress.
